India – Marching towards 10 Trillion USD Economy

MoPNG, Government of India, reported in the Annual Report that India's oil demand is expected to rise from the existing 4 million barrels per day to reach 8.7 million barrels per day by 2040.

The India story is dynamic and promising for the coming decade. While India moves towards 2047, the next seven years are vital. India has fared better, showing much resilience despite global uncertainties and economic crises. With an average growth rate of 5.5% over the past decade, India has already become the fastest-growing economy in the world and is set to double its current annual GDP of close to USD 3.5 trillion to USD 7 trillion by 2027 and to USD 10 trillion by 2030. The IMF has pegged India as the 'bright spot' and a key contributor to global growth that 'will alone contribute 15% of the global growth in 2023. The fifthlargest economy in the world, India is all set to be the third-largest by 2027.

India had clocked a 7.2 per cent GDP growth in the 2022-23 fiscal year. Commerce and Industry Minister Piyush Goyal had called it "historic," adding that India would emerge as a developed nation in the next 25 years. There's a clear focus by India's government to become a hub for foreign investors as well as a manufacturing powerhouse under the Aatmanirbhar Bharat mandate.

The global Lubricants & Grease market size was estimated at USD 134.65 billion in 2022 and is projected to grow at a compound annual growth rate (CAGR) of 4.0% from 2023 to 2030. This is attributed to the growing demand for automotive oils and greases due to the growing trade of vehicles & spare parts, infrastructure, metal, cement, chemical, mining industries, etc. Lubricants & Greases are an essential part of rapidly expanding industries. As per an estimate, the Indian Grease market is expected to grow from 180 TMT to 250 TMT by 2030 at a 4% CAGR. It gives ample opportunities to all Grease producers and marketers to introduce both products for masses and classes. All stakeholders of the Global Grease industry are expected to focus on India and its subcontinent for the overall growth of their organizations.

















NLGI - INDIA CHAPTER

The India Chapter of NLGI-USA was formed in 1997, and it has since been very active, rendering services to the Indian grease industry by conducting education courses on various grease-related subjects relevant to consumers/manufacturers, organising round-robin tests on various test methods, conducting grease conferences, and publishing the quarterly journal "Greasetech India." This Society has membership from all the major petroleum industries in the public and private sectors, as well as other related industries and institutes. research etc. The primary objective of this Society is to bring the industry-related personnel, including consumers, onto a common platform so that their mutual business interests can be discussed and shared. 
